## **Office Paperwork**

Just a reminder that small vehicle registration and proof of up-to-date septic maintenance/pumping will be required prior to picking up swim bands in 2024.

So, in the spring, when members pick up their swim bands, small vehicle owners (aka golf carts, ATVs, small dirt bikes) will need to provide proof of current insurance to complete the registration process. Homeowners will also need to ensure that a current copy of their septic pumping/maintenance is on file prior to receiving their bands.
